Terms of Reference

1. The REMC will meet once in 2 (two) months to review the applications and proposals, preferably on the last Saturday or as decided by the Chairperson.
2. Proposals directly or indirectly benefiting the State / Government and build local capacity will be encouraged.
3. The REMC shall recommend or not recommend or suggest modification to any research project that may be referred to it and forward the same to the Forest Environment & Wildlife Management Department for necessary action.
4. It shall also monitor ongoing research projects and if not found satisfactory recommend withdrawal of permission to it.
5. It shall also engage in preparation of research projects pertaining to floral/ faunal biodiversity related issues including climate change, human-wildlife conflict etc. either on its own or in collaboration with Sikkim Biodiversity Board and other local/ national institutions.
6. The REMC shall propose new research to be conducted by the Department either by itself or in collaboration with recognized institutions and seek funding from Government or NGOs or other agencies.
